INDIVIDUAL INSTRUCTIONS

Court-sponsored foreclosure mediation is limited to homeowners whose principal residence (1 to 3 family) is the subject of a foreclosure action. The homeowner must be the borrower and not in bankruptcy. This is an opportunity for all parties to negotiate a mutually acceptable settlement. A request for mediation does not stay or otherwise delay the foreclosure action. There are several possible solutions that you and your lender can explore. Many of your initial questions can be answered by accessing the NJ Judiciary Foreclosure Mediation Program website.

In addition to this request statement and financial worksheet, if you are seeking a loan modification, a loan modification checklist can be accessed at <u>njcourts.com</u> which will guide you in collecting and submitting the documents needed as well. To find a Housing Counselor in your county, see the list of Housing Counseling Agencies at the <u>New Jersey Housing and Mortgage Finance Agency</u> web site.

1. Complete the **Mediation Request Statement**.

Fill out Homeowner's Foreclosure Prevention Proposal and or discuss with Housing Counselor.

SECTION C:

Housing Counselor must provide Housing Agency/ Housing Counselor Contact Information, sign & date (if applicable).

SECTION D:

Complete the Homeowner Contact Information at the bottom of the page.
